# Employment First MA

Passed in July 2010, this policy establishes integrated, individual employment is the <u>preferred service option</u> and <u>optimal outcome</u> for workingage adults served by the Massachusetts Department of Developmental Services (DDS).

Exposure to work activities and skill development is key for CBDS to serve as a pathway to employment when/if the person chooses to work.



# CBDS Definition

# Massachusetts DDS defines CBDS as follows:


Community-Based Day Supports (CBDS)- (Activity Code 3163) - This program of supports is designed to enable an individual to enrich his or her life and enjoy a full range of community activities by providing opportunities for developing, enhancing, and maintaining competency in personal, social and community activities.





# CBDS is NOT:

- A replacement for paid employment.
- A prerequisite for employment.
- Activities just to fill time.
- Activities that individuals are "plugged" into.
- Random activities just to keep people busy.
- Simply fun, recreational activities.









Pre-planned CBDS activities should promote the full integration and inclusion of individuals with disabilities into mainstream society through positive community contributions and relationship development.

## **Core Service Values**

**Person-centered** 

An approach that values an individual's unique skills and interests and incorporates them into service planning.

Integrated

Services are conducted in integrated community settings as much as possible.

**Purposeful** 

Daily activities are designed to meet individual goals.



# Identifying Activities

It starts with the person and should be driven by the person.



### **DEVELOP A PROFILE**




Search for Opportunities & Talents



- History (living, working, learning, recreation)?
- Relationships?
- Locations (shopping, dining, previous employers, desired places to work)?
- Preferences & desires for employment? New experiences or adventures?
- Are there environmental factors to consider?
- Are there any individual needs to be considered? (accommodations & assistive technology, communication device)

\*Situational assessments can help explore tasks & environments and help better inform the profile in time.




